
# 1. Introduction and methodology

- 1.1. This report comprises a Sustainability Appraisal (SA) of the pre-submission draft Drayton Neighbourhood Plan. It has been developed to test and inform the content of the emerging Plan as required by the EU Directive 2001/42/EC, which is also known as the Strategic Environmental Assessment (SEA) Directive.
- 1.2. Although the SEA Directive only requires Neighbourhood Plans to undertake a Strategic Environmental Assessment (SEA), in order to ensure best practice this report reviews social and economic issues and therefore comprises a broader Sustainability Appraisal.
- 1.3. By undertaking an SA rather than an SEA, the Drayton Neighbourhood Plan Forum (see below) is ensuring that policies are tested against social and economic appraisal criteria as well as environmental criteria.
- 1.4. This SA follows the issuing of a Screening Opinion provided by Broadland District Council (BDC) and the subsequent production of an SA Scoping Report.
- 1.5. The SA Scoping Report was subjected to a formal consultation with relevant statutory agencies. A number of modifications to the Scoping Report were made in response to suggestions from Natural England, Norfolk County Council and English Heritage. The Environment Agency did not respond to the consultation and confirmed that they would not due to a lack of resources.
- 1.6. This SA reflects the modifications on the SA Scoping Report recommended by these statutory agencies.

### **Location and Local Government administrative context**

- 1.7. Drayton is in the English county of Norfolk. It is located close to the north western edge of Norwich and is around five miles from Norwich city centre. The Parish is located within the Local Authority District of Broadland.
- 1.8. The Parish is bounded by the Wensum River Valley to the south which forms part of the Parish of Costessey (South Norfolk District). To the west the Parish neighbours Taverham Parish, to the north, Horsford Parish and to the east Hellesdon, all of which are within Broadland District.
- 1.9. The surrounding Parishes to Drayton are built up to a lesser or greater degree, with Taverham, Hellesdon and Costessey being largely urban and Horsford more rural.
- 1.10. The Drayton Neighbourhood Plan boundary is contiguous with the boundary of the civil Parish of Drayton (see below).

- 1.11. As noted above, Drayton Parish is located within BDC's administrative area which is the local planning authority for the purpose of this Neighbourhood Plan. Reflecting this, this SA Scoping Report considers the plans, policies and sustainability issues in Broadland District.
- 1.12. Strategic planning policy for the BDC area is provided by the Greater Norwich Development Partnership Adopted Joint Core Strategy (2011) which sets out the strategy for growth in Norwich and the surrounding area including Drayton up to 2026. The Joint Core Strategy is based on targets for growth set out in the defunct Regional Spatial Strategy for the East of England (2008).
- 1.13. The Greater Norwich Development Partnership is a partnership between Broadland, Norwich and South Norfolk District Councils who are working together to develop long term plans for housing growth and jobs in the Greater Norwich area.
- 1.14. Other BDC strategic planning policy documents taken into account in the preparation of this SA Scoping Report include the Site Allocations DPD Preferred Options Report (2013) and the Development Management DPD Issues and Options Report (2011).

### **Background to Sustainability Appraisal**

- 1.15. Sustainability Appraisal is a systematic process undertaken during the preparation of a plan or strategy, as required by the Planning and Compulsory Purchase Act 2004 (S19(5)).
- 1.16. There is also a requirement for Development Plan Documents such as Neighbourhood Plans to undergo an environmental assessment, (known as a Strategic Environmental Assessment) under European Directive 2001/42/EC (transposed into UK legislation by the Environmental Assessment of Plans and Programmes Regulations 2004).
- 1.17. It is intended that this Sustainability Appraisal incorporates the Strategic Environmental Assessment in accordance with the regulations.
- 1.18. The Sustainability Appraisal process will:
  - Adopt a long-term view of development within the area covered by the plan, with particular interest on the social, environmental, and economic effects of the proposed plan
  - Develop an effective system for ensuring that sustainability objectives are transformed into sustainable planning policies
  - Reflect global and national concerns, as well as concerns at the regional and local levels
  - Provide an audit trail of how the Neighbourhood Plan has been revised to take into account the findings of the sustainability appraisal.
  - Incorporate the requirements of the Strategic Environmental Assessment Directive
  - Produce and consult on a Scoping Report early in the process for the plan.
- 1.19. Government guidance on undertaking Sustainability Appraisal of Local Development Documents (of which the Neighbourhood Plan will be comparable to) presents a five-stage

process, each of which contains criteria to fulfil that requirement. These stages are described in Government guidance in the following manner:

- 1.20. Sustainability Appraisal is an iterative and on-going process. However, in relation to the table above, Stage A has now been completed.
- 1.21. This report represents a summary of Stage B and the outcome of Stage C.
- 1.22. The six main tasks within Stage B have been completed and are set out in this document. The table below illustrates the specific tasks.

### **Drayton Neighbourhood Plan**

- 1.23. The Drayton Neighbourhood Plan will be a Neighbourhood Development Plan for the Parish of Drayton. The power to produce neighbourhood plans is an output of the Localism Act (2011).
- 1.24. The aim of neighbourhood planning is for local communities to have greater control over what happens in their area.
- 1.25. The process of producing the Drayton Neighbourhood Plan is being undertaken by the Drayton Neighbourhood Planning Forum, a sub-committee of Drayton Parish Council.

- 1.26. The Drayton Neighbourhood Planning Forum comprises representatives from the local community and organisations as follows:
  - Drayton Parish Council
  - Drayton Community Infant School
  - St Margaret's Parish Church
  - Bob Carter Centre
  - Drayton Tree Wardens
  - Local residents.
  - Broadland District Council.
- 1.27. The Drayton Neighbourhood Planning Forum has been in operation since February 2013. Since that time it has held a number of meetings to discuss baseline information, a Neighbourhood Plan vision, objectives and has developed a series of draft policies.
- 1.28. The Drayton Neighbourhood Planning Forum organised and held a first phase of open public consultation events on Thursday 8<sup>th</sup> May (King George V Pavilion), Friday 9<sup>th</sup> May (Bob Carter Centre) and Saturday 10<sup>th</sup> May (Thorpe Marriot Village Hall), 2014.
- 1.29. At the events, attendees from the local community were asked to record what they liked and disliked about the village and what they would change. Attendees were also asked to give their opinion on a draft vision statement prepared by the Drayton Neighbourhood Planning Forum, and review a series of objectives for the Drayton Neighbourhood Plan. The draft vision and objectives are set out below.

#### Vision

The Vision of the community of Drayton is based on their desire to maintain the quality of life in their parish by preserving the balance between the built and green environment, improving negative elements of the built environment and infrastructure – whilst developing and strengthening opportunities for the people of the Parish, encouraging increased prosperity, and building up the facilities available to residents, and those that work here.

#### Objectives

- 1. Preserving the character of the settlement, including the spatial balance between the rural/built environment, historical assets and character, improved design based on local vernacular styles
- 2. Protecting and enhancing resources available for sports, leisure, community and educational activities
- 3. Facilitating improvements in road transport, traffic, and parking
- 4. Improving the management of and possibly increasing the provision of public green spaces of different kinds
- 5. Supporting businesses and local employment
- 6. Improving access and use of route-ways through both urban and countryside for pedestrians and cyclists
- 7. Prioritising local housing need.
- 1.30. Following this initial public consultation event, the Neighbourhood Planning Forum identified a number of issues to address through the creation of Neighbourhood Plan policies. These initial policy ideas reflected comments received from the local community

at the May 2014 consultation events, the views of the stakeholders that make up the Working Group, the results of a process of baseline research and the results of a survey of residents undertaken during the preparation of a Parish Plan.

- 1.31. The initial policy ideas were tested at a second consultation event on 22<sup>nd</sup> June 2014 at the Drayton Village Fete and modified accordingly.
- 1.32. Finally, an initial draft of the full policies were the subject of a third consultation event on Thursday 30<sup>th</sup> October (King George V Pavilion), Friday 31<sup>st</sup> October (Thorpe Marriot Village Hall) and Saturday 1<sup>st</sup> November (Bob Carter Centre), 2014.
- 1.33. Responses and input from the local community were then fed into the policies and a number of revisions and amendments were made. The policies were also reviewed informally with officers from Broadland District Council in order to test their conformity with strategic planning policy and by the Working Group itself prior to the production of the Pre-Submission Consultation Draft.
- 1.34. The policies resulting from this process of development and testing are presented in the Pre Submission Draft Neighbourhood Plan and are appraised in this document.

#### **SA** report structure

- 1.35. The remainder of this document is structured as follows:
  - Section 2 provides an appraisal of the draft Neighbourhood Plan objectives against the SA objectives
  - Section 3 provides an appraisal of the draft Neighbourhood Plan policies against the SA objectives
  - Section 4 concludes the SA report and outlines next steps in the Plan's development.

## 2. Appraisal of draft Neighbourhood Plan objectives (Task B1)

- 2.1. The purpose of this task of the SA is to assess the sustainability of the draft Neighbourhood Plan objectives against the SA objectives set out and tested in the SA Scoping Report.




Figure 4b: Feedback on the draft objectives from May 2014 consultation event

- 2.2. The draft Neighbourhood Plan vision and objectives were developed to reflect the views of the Neighbourhood Planning Forum and background research. They were tested with the general public at the public consultation event in May 2014. The results of the public consultation event in relation to this component are presented in Figures 4a and 4b below which demonstrates broad support for all of the proposed objectives.
- 2.3. However, the objective relating to local economic development was met with a mixture of confusion and objection and was therefore revised to 'Supporting businesses and local employment' (this is reflected in the previous section which provides the most up-to-date version of the objectives).
- 2.4. The SA objectives were developed during Stage A of the SA process. They were tested with statutory agencies during the SA Scoping Report consultation.




Figure 5: Sustainability appraisal of Neighbourhood Plan objectives

- 2.5. The results of the appraisal of the draft Neighbourhood Plan objectives are presented in Figure 5 below. The figure illustrates that all of the draft Neighbourhood Plan objectives are compatible with the SA objectives.

# 4. Conclusions and next steps (Task B6)

### **Appraisal of policies**

- 4.1. The appraisal tables in the previous section highlighted that the majority of draft
  Neighbourhood Plan policies will have either positive or significant positive effects on the
  environment, community and economy. Only one policy (policy 4) is considered likely to a
  negative effects on one particular objective.
- 4.2. Where a policy (policy 4) is estimated to have a potentially negative effect, the negative effects are outweighed quantitatively by the positive effects. Mitigation measures are suggested that would be addressed through the conventional development control process that could alleviate any negative impact.

## Monitoring

4.3. Following adoption, the effects of the Drayton Neighbourhood Plan will be monitored by Drayton Parish Council. The monitoring framework, indicators / criteria and data sources are set out in the SA Scoping Report.
